#### **New Business**

Obtaining Boiler Experience

Dale Trombley asked for suggestions on how someone with a Class IV Boiler Fireman certification can obtain the required operating experience, through volunteering, to meet the eligibility to test for the Class III Operating Engineer.

Samuel Cureton mentioned that he is in the process of trying to start a volunteer program. He will share more information when it is set up. Christopher Jackson mentioned looking at companies like WestRock, NW Boiler and Reitmeier Mechanical.

### Good of the Order

Joel Rasmussen mentioned he is monitoring the Washington State Energy Code regarding floor radiant systems, which use bigger water heaters. Depending on changes to the code certification may be required, not necessarily monitoring.

Yifan Sun, the new dean over the boiler certification program, gave a brief introduction and mentioned the other departments she oversees. Prior to Bates, she worked at Shoreline Community College as the International Education Manager.

Additional Bates updates from Amelia Fortuno:

- Less than 100 boiler operators still need to renew their certificate
  - Certificates are in the 45-day grace period, which ends on September 15
- ctcLink (project to get all Washington community and technical colleges on PeopleSoft)
  - Deployment Group 6 has been broken into three groups
    - Bates will be in the third/last group which goes live on May 9, 2022
- Revised boiler exam application form
  - Plans are to implement in January 2022
