Is the college still open?

Yes we are, and we are accepting new students to participate in our hybrid classes.

What is hybrid learning?

Hybrid learning uses tools that allow students to receive instruction remotely. Lab learning is completed in limited size labs designed with social distancing in mind.

What if I don't have a computer?

Is lab learning safe?

If your program requires hands-on learning in a lab, please know that we are taking extra precautions to keep everyone safe. Labs will be offered in shifts to minimize the number of students in the lab at one time. Cleaning of labs is happening regularly. Sanitation supplies are available in all labs for your use.

What about classes that require clinical, inter/internships or other workplace experiences?

Students taking classes that require workplace experience (e.g. clinicals, internships, externships, practicums, etc.) should check with their instructors, who are receiving regular updates from workplace partners and will be able to communicate directly with students.
